- Rules:** All YMCA guidelines and regulations covering warm-ups and deck Personnel will be followed. All rules and safety procedures will be followed.

- Check-In:** All swimmers must check-in by 9:15am
- Time Trials:** Time trials will be available at the end of the session for a fee of \$5/event and \$20/relay. Swimmers must sign-up by the beginning of the breast-stroke events (event # 75)

- Entry Fees:** \$4/ individual event and \$16/relay
