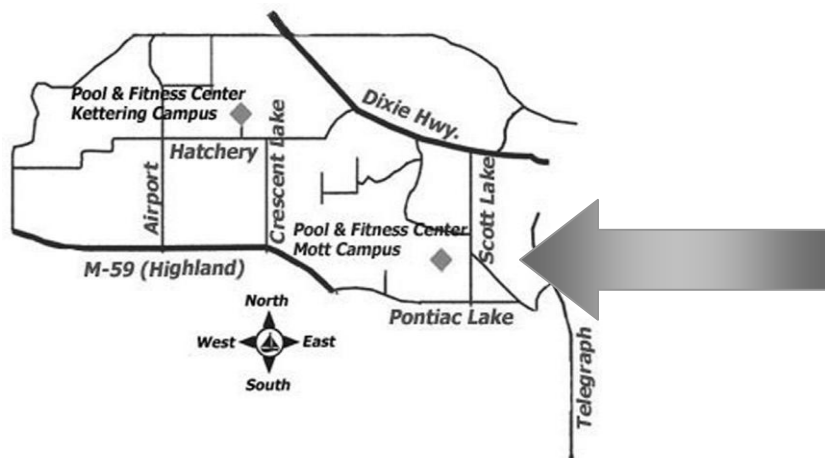

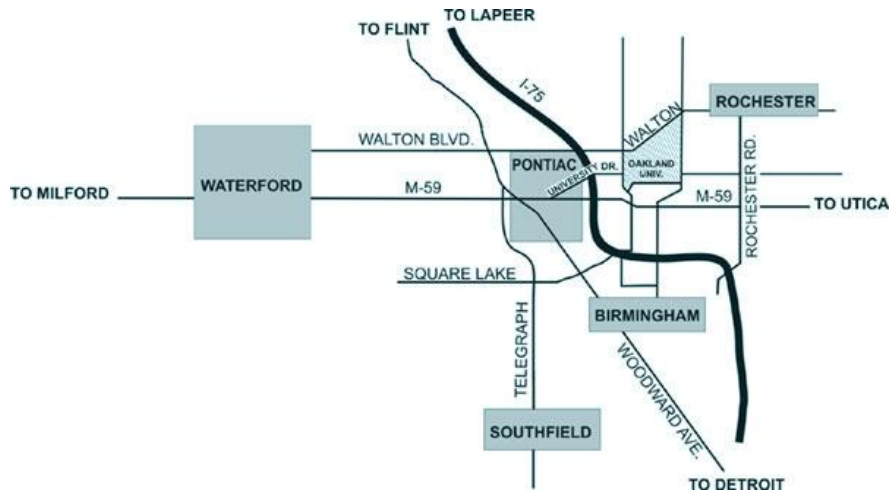
Date and Time: **Saturday, February 18, 2012** 9:30 am Warm-up, 10:30 am Start

Facilities: The Waterford Mott Pool has an eight lane, 25-yard x 25 meter competitive pool for lap swimming or diving. And has an elevated seating for 400 spectators located on two sides of the competition pool. The Pool also has handicapped accessible ramps

A Colorado timing system with an 8-lane scoreboard and manual back-up timers will be used for all events. A second pool will be available for continuous warm-up during events. Locker room facilities are available, but swimmers must provide their own locks.

The Flint YMCA Falcons and Waterford Mott High School are not responsible for lost, damaged or stolen property. For the safety of all those attending the swim meet, no one will be allowed to roam outside the pool area around the school facilities.





Eligibility:

Only certified associations are eligible to compete in this event. An association is a YMCA unit that is 1) certified by the National Board, 2) holds an association, branch, or unit number, 3) is eligible for separate listing in the YMCA directory. A branch, department, or center of a Metropolitan Association is considered an association for purposes of this event.

A swimmer must be a full-time member of the YMCA he/she represents for at least 90 days prior to this event and must have represented only that YMCA in any open competition that he/she participated in during the current season, Sept. 1, 2011 through April 30, 2012. A swimmer may not represent more than one YMCA in competitive sports.

The swimmer's age is determined by his/her age as of December 1, 2011.

Entry Limits:

Each swimmer may enter a maximum of three individual events and two relays.

Deck Entries:

Deck entries will not be accepted for this event.

Seeding:

This meet will be pre-seeded. All events are timed finals and will be seeded slowest to fastest.

Marshaling:

Marshaling will take place on deck. Relay cards will be provided to coaches at the beginning of each session. They must be returned to the Meet Scorer with swimmers' names and swim order 30 minutes prior to the start of the session.

Anyone willing to officiate at the meet is welcome and appreciated. Officials must be YMCA certified. If you are interested, please contact David Roberts at david.roberts@gm.com.

Warm-up Procedures: Controlled, supervised warm-up sessions will be utilized in accordance with the warm-up procedures suggested by YMCA swimming. Warm-up lanes will be assigned in order to balance the number of swimmers per lane.

During the final 20 minutes of warm-up, lanes 1, 2, 7, and 8 will be dedicated as one-way sprint lanes, with diving or backstroke start, one length swim, and then exit at the other end of the pool. Additional sprint lanes will be assigned if required at the direction of the Meet Referee.

Awards: Awards will be given for places 1-12 in individual events and places 1-6 in relays. Medals will be awarded for first through sixth place and rosette ribbons will be awarded for places 7-12.

Team Scoring: Team points will be awarded based on the top twelve finishes as follows:

Deck Personnel: Only swimmers, coaches, and meet workers are allowed on deck.

Each team participating in this meet is requested to provide timer(s) to staff this event. We request that your designated timers be at least 16 years of age, and have some previous timing experience.

Teams with less than 10 swimmers participating - requested to provide one timer.
Teams with 10 or more swimmers are requested to provide two timers.

The Entry Summary Form contains a section to identify your team's designated timer(s).
