**Location:** Grand Haven High School

**Directions:** **From US 31:** From the north: Follow US 31 south through town to Ferris St. Turn right on Ferris and take the first driveway on the right into the high school facility. The pool is located at the north end of the building and has its own entrance.

**Parking:** Parking in the north parking lot closest to the football field for the shortest walk to the pool.

**Times:** Warm-up: 8:00am  
Meet: 9:00am

**Facilities:** Grand Haven Aquatic Center is a 25-yard, 8-lane pool. The Colorado Timing System will be used for all races over 25 yards. Grand Haven High School, MYST assumes no responsibility for lost articles. No smoking is allowed in the building. Due to building regulations no food is allowed on deck or in the bleachers. We appreciate your cooperation in keeping this facility in great condition.

**Eligibility:** The Muskegon MYST Pentathlon is a closed Y meet.

**Meet Format:** The MYST Pentathlon has a timed finals format.

**Entry Limit:** Swimmers may enter all five (5) or fewer events in their age group. However to be eligible for high point winner, a swimmer must have participated in all five events.

**Entry Fees:** \$5.00 per individual event.

**Entry Procedures:** Team entries only (Hytek preferred). All entries should be submitted via e-mail to the entry chairperson, **Margie Collison at [someryeats@aol.com](mailto:someryeats@aol.com)**. Entries may be submitted to the chairperson beginning October 06, 2011. **The entry chairperson must receive all entries no later than 11pm November 6, 2011.** If your team's money is NOT received by the day of the you're your swimmers will not be allowed to participate. - Check In:** All swimmers **MUST** check in. Check in will be available 30 minutes before the start of warm-ups. **Check in will close 15 minutes after warm-ups begin.**
- Marshalling:** 10&U swimmers will be marshaled with self marshalling for 11 & Up swimmers.
- Seeding:** Seeding will be done after check in closes. Swimmers who fail to check in will be scratched from the meet. All events are timed finals and will be seeded from slowest to fastest.
- Deck entries:** There will be no deck entries.
- Meet Programs/  
Admissions:** \$4.00 per person. Children 12 & U with an adult are free. Event programs will be available for \$ 1.00.
- Awards:** Medals will be awarded for 1<sup>st</sup> thru 6<sup>th</sup> place and ribbons 7<sup>th</sup> thru 12<sup>th</sup>. High point trophy will be awarded to a boy and girl in each age group. No team awards.
- Results:** Complete results will be posted in the hall and a copy will be mailed to each team.
- Concessions/  
Vendors:** Food and beverages will be available at the concessions area adjacent to the entrance of the spectator viewing area. No food or beverages will be allowed on the deck of the pool, in the locker rooms or in the spectator areas. A hospitality area will be available for the coaches and officials. Action Accents will provide swim gear for sale.
- Lost and Found:** Articles may be turned in/picked up at the marshalling table. Articles not picked up at the end of the meet will be retained by Margie Collison (MYST Coach) for at least 14 days and then donated to charity.
- Deck Personnel:** Only swimmers, registered coaches and meet officials/workers are allowed on the pool deck.
- Swimmers with  
Disabilities:** All swimmers are encouraged to participate. If any of your swimmers have special needs or requests please submit them with your team's entries.

**Facilities Items:**

(A) No smoking is allowed in the building or on the grounds of Grand Haven High School.

(B) Pursuant to applicable Michigan law, no glass will be allowed on the deck of the pool or in the locker rooms.

(C) No bare feet are allowed outside of the pool area. Swimmers need to have shoes to go into the hallway or concession area.
